AP Superspeciality dental hospital, Vijayawada, Andrapradesh.

HEREBY agrees to establish collaboration according to the terms and conditions set out in the articles below.

Article I: Recognition of dental clinic

The APSuperspeciality dental hospital has been considered by the St. Joseph dental college as a centre having advanced dental equipments to perform diagnosis and treatment of various oral conditions. Also the AP Superspeciality dental hospital has sufficient patient OPD to allow better learning experience for the students of the SJDC.

Article II: Student training programme

The AP Superspeciality dental hospital will provide an opportunity twice a year for the students of SJDC. The students will abide with the rules framed by the doctor of the dental clinic. The doctor will briefly explain all the facilities available in the dental clinic and explain the treatment protocol. The students will be permitted to only observe the cases performed by the doctor(s) of the dental clinic. Duration of student stay in the dental clinic will be for maximum of one week.

Article III: Finance

The logistic cost (stay, food, travel) will be entirely looked upon by the St. Joseph dental college. The AP Superspeciality dental hospital will not have any role in the logistic aspect of the students.
