Article III: Information on the new materials and techniques in the field of endodontics

Many endodontic and restorative materials will be introduced first in the United States. Many materials are first made commercially available in the United States. Article IV: Finance and funding

The cost of procurement of materials from United States will be entirely borne by the Staff and/or students of SJDC.

Article V: Duration

This agreement will become effective upon the date of signature by both parties. It shall remain valid for period of five years from the date of last signature, with the understanding that it may be modified by written mutual consent of both parties.
