HEREBY agrees to establish collaboration according to the terms and conditions set out in the articles below.

## **Article I: Recognition of dental clinic**

The Paruchuri dental clinic has been considered by the St. Joseph dental college as a centre having advanced dental equipments to perform diagnosis and treatment of various oral conditions. Also the Paruchuri dental clinic has sufficient patient OPD to allow better learning experience for the students of the SJDC.

## **Article II: Student training programme**

The Paruchuri dental clinic will provide an opportunity twice a year for the students of SJDC. The students will abide with the rules framed by the doctor of the dental clinic. The doctor will briefly explain all the facilities available in the dental clinic and explain the treatment protocol. The students will be permitted to only observe the cases performed by the doctor(s) of the dental clinic. Duration of student stay in the dental clinic will be for maximum of one week.

This memorandum of understanding completed in English is hereby signed in two (2) copies with one (1) copy remaining in the possession of each institution.


