and

**St. Joseph Dental College and Hospital** at the address Duggirala, Eluru, Andhra Pradesh - 534003, INDIA; represented by its Secretary & Correspondent, Rev. Fr. Gorremuchi Moses.

Whereas the parties are convinced that cooperation between and exchanges of Academic Staff and Students will be of great personal benefit to the participants themselves in their Teaching and Research.

Both universities agree to the following provisions:

**Article I**

The contracting parties will foster the existing relations in the sphere of Educational and Scholarly Cooperation and develop new relations on the ground of mutual benefit and full reciprocity.

**Article II**

The cooperation will involve, under the terms specified in the cooperation agreement, the faculties and the research centers of Semmelweis University and St. Joseph Dental College and Hospital.

**Article III**

Both parties shall, under the terms specified in the cooperation agreement and the other agreements they conclude, exchange Junior/Senior Academic Staff and/or Students.

Applications of candidates including outlines of the program to be carried out abroad are subject to the approval of the host institution (the representative of the University and the representative of the respective faculty or the representative of the respective Research center). Both parties shall, under the terms of a separate agreement, promote and jointly sponsor Joint Research projects in areas where their interests correspond.

#### Article IV

Both parties shall, under the terms specified in the cooperation agreement and the other agreements they conclude, explore the possibility of Organizing Conferences, Symposia, Seminars and Workshops.

#### Article V

Any changes and amendments in the text of this Memorandum of Understanding shall be introduced only in writing, and after the prior mutual consent of both parties. These changes and amendments shall be treated as integral parts of this Memorandum of Understanding.

#### Article VI

The term of this Memorandum of Understanding shall become effective upon mutual execution and continue in effect for Five (05) Years. Each party reserves the right to terminate this Memorandum of Understanding upon three months written notice to the other party. The agreement can be renewed for an equal period, by mutual written agreement.

#### Article VII

Each Party will appoint Academic, Scientific and Administrative Coordinator (herein after called as Coordinator) to facilitate the collaborative activity at the respective home Institutions.
