HEREBY agrees to establish collaboration according to the terms and conditions set out in the articles below.

Article I: Joint research activities.

Research activities of mutual interest will be discussed. Research projects will be designed by the participating members of both the institutions and a research team will be formed consisting of postgraduate students, Staff from SJDC and Dr. Surya Bharat.

Article II: Student training program

Dr.Surya Bharath being excellent clinician and expert in the field of endodontics and aesthetic dentistry will share his clinical views on various topics and will provide in depth knowledge on performing various clinical procedures. Dr. Surya Bharath will present his clinical cases ranging from root canal treatment, fractured instrument retrieval, composite restoration, post and core and indirect adhesive restorations.
