2. RESPONSIBILITIES OF DENTAL COLLEGE

The college agrees to:

1. **Waste segregation:** Segregate waste at the source into biodegradable & non-biodegradable as per regulatory guidelines.
2. **Storage and Handling:** Store waste in designated bin.
3. **Safe disposal and Practices:** Ensure that waste is properly collected and handed over to an authorized waste management agency.
4. **Training and Awareness:** Conduct training programs for students and staff regarding waste disposal methods.
5. **Compliance with Regulations:** Adhere to all applicable laws of solid management rules, 2016

3. RESPONSIBILITIES OF GRAMA PANCHAYAT:

1. **Waste collection:** Arrange for the regular collection of non-bio medical solid waste from the college premises.
2. **Disposal Infrastructure:** Ensure that the collected waste is transported to an authorized waste treatment and disposal facility.

4. DURATION AND TERMINATION

2. Either party may terminate this MoU by giving a **30 days**, written notice to the other party.
3. In case of non- compliance with the agreed terms, necessary corrective actions shall be taken before termination is considered.
4. Any dispute arising under this MoU shall be resolved amicably through mutual discussions. If unresolved, the matter shall be referred to arbitration as per applicable laws.
