Vide reference cited, detailed schedule was issued prescribing various preparatory activities that need to be completed before release of the next instalment of fee by the government under Jagananna Vidya Deevena scheme.

Eligibility of student for receiving the JVD scheme will be dependent on following parameters:

- a) Eligibility as per five- steps validation done in village/ward secretariats, subject to disposal of any objections filed, if any, in social audit
- b) Eligibility as per six-steps validation done at state level, subject to disposal of any objections filed, if any, in social audit
- c) CET- Convenor quota status validation
- d) Completion of bio metric authentication by students
- e) Completion of OTA by Principals and District Welfare Officers
- f) Entry of fee for the course in the portal
- g) Remittance of scholarship received for previous discontinued course, wherever applicable.
- h) 75% attendance of student as entered in logins of colleges

The various activities that need to be completed by the Colleges are reiterated hereunder for ready reference of all the Principals/ Heads of the Institutions registered in jnanabhumi portal.
